site. With 33 airlines serving this airport, there are more direct flights than most locations in the U.S.

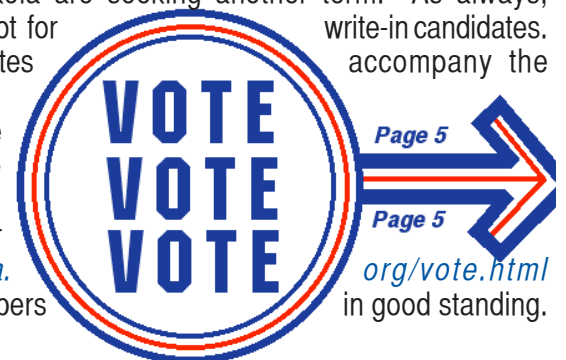

# Lifetime Of Safe Flying, Instructing Earns Jim Hart FAA's Prestigious Wright Brothers Master Pilot Award

How has Jim Hart found the time? He has been head of public relations for a number of major corporations, winning PRSA honors for his work. He is a lawyer. He spent many years on active duty and in the Air Force Reserve rising to the rank of brigadier general as the mobilization assistant to the SAF/PA director. Currently Jim is the AFPAAA treasurer and holds a similar post with his church.

What's more, he is the Chief Flight Instructor of the North West Florida Flying Club, giving check-rides, flight reviews, instrument proficiency certifications, as well as basic pre and post solo training for students working on their private pilot's license.

Flying is not new to Jim, and it is his accomplishments as a pilot that have earned him his latest honor, the Federal Aviation Administration's Wright Brothers Master Pilot Award.

That's quite an honor.

You have to fly a lot over a long period of time to get it. The award requires 50 years in the cockpit from the time of your first solo, including military and civilian flight time; that you hold an FAA pilot certificate for those 50 years, and you can't have any disqualifying blemishes on your record.

It's a pretty prestigious award. With more than 800,000 pilots in the United States, since the award was established in August of 2003 only 1477 pilots have received it.

Jim, who is 74, soloed in a T-34 in 1958 as an Air Force Aviation Cadet. He obtained his private civilian license in 1961 and now has more than 6,000 hours in the air.

He has owned a Great Lakes Bi-Plane in which he taught aerobatics. Most of his single and multi-engine time has been in Piper's and Cessna's. Currently he pilots a Cessna 172 and 182, and a Beechcraft twin-engine Baron. He holds current FAA Flight Instructor Ratings for single engine, multi-engine, and instruments.

The most harrowing experience he had in the air occurred on November 14, 1965 when the single-engine Piper he was flying almost had a mid-air collision with a United Airlines DC-7. It was a flight that led to the



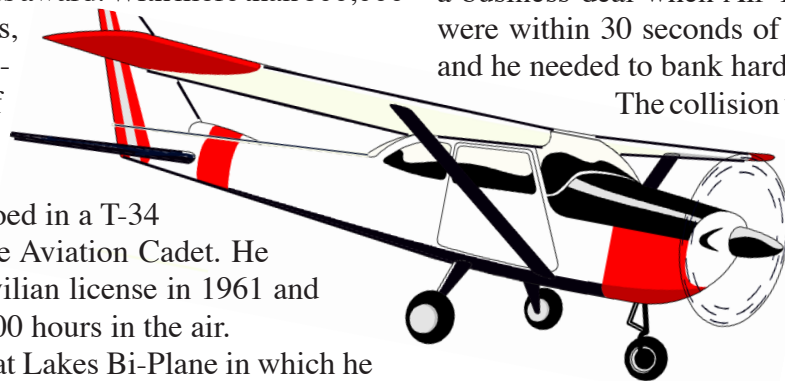

founding of Habitat for Humanity. Businessman Millard Fuller was Jim's passenger on a flight from Niagara Falls to New York City where they were going to close a business deal when Air Traffic Control warned they were within 30 seconds of a collision with the airliner and he needed to bank hard right. He did.

The collision was avoided as the Piper was buffeted by turbulence from the DC-7 which flipped it in the opposite direction before Jim regained control.

Fuller's autobiography tells how the flight changed his life. He ended his interest in the business he was en route to close a deal on, eventually formed Habitat For Humanity, and embarked on other charitable ventures.

That flight made Jim "more aware of the meaning of life and how God picks people for future things . . . had we been hit instead of barely missed, there would be no Habitat for Humanity . . . Millard Fuller lived to do a lot to help other people's lives."

**Dick Abel** has been served two terms on the board. An internationally known speaker on family values, military affairs, and moral leadership and author of Leadership Is ALL About People, he is president of the instructional program of the same title, a seminar for people who desire to impact the lives of others. He is also ambassador at large and executive director emeritus of Military Ministry, a division of Campus Crusade International. A retired Air Force brigadier general and jet pilot, during his 30-year military career, he led an Air Force acrobatic team, was an assistant football coach at the U.S. Air Force Academy, escorted home five flights of returning POWs from Vietnam, served as special assistant to three four-star Navy admirals and one chairman of the Joint Chiefs of Staff, and was director of Air Force Public Affairs.

**John Gura** spent 21 years in the Air Force retiring as a Lt. Colonel in 1983. As a PA, John held wing, MAJCOM, and SAF/PA jobs including stints as Chief of the Chicago field office and Department Director and Deputy Commander of DINFOS. Subsequently, he held corporate marketing and video production positions until helping found HomeSafe Environmental, Inc. a California environmental training and testing firm in 2000. He developed and continues to provide support for the AFPAAA web site and the Oral History Program. John served previously as Association President and Chairman.

**Jim Hart** Over the years since, AFPAAA was formed; it has been my privilege to support our Association in many ways. Currently I am serving as your Treasurer. Although board membership is not required to hold this position, I believe that all officers should also stand for election to the board. As past Chairman of the Board, I am an ex-officio member of the board but that does not entitle me to vote. Your Treasurer, like all other officers of AFPAAA, should be a voting member of the board. So I ask for your support.

**Hank Hufnagel** has served on the AFPAAA board for a number of years and has been active on the Endowment Fund Investment Committee since 2002. He joined the Air Force in 1964, after graduating from Arizona State University. He hold a Master of Science degree from the University of Colorado and has completed numerous military professional education schools including the National Defense University's National Security course. His assignments include tours of duty in Viet Nam, USAFE, and the Strategic Air Command. His last assignment was at the U. S. Strategic Command, Offutt AFB, NE. He retired in 1994. After leaving active duty in 1973, he has held various financial, sales and management positions with Boeing, General Electric, McDonnell Douglas, Morgan Stanley, H & R Block Financial Services (now Ameriprise). Hank is a CPA and is Vice President of investments at the Chicago Investment Group. He resides in Wilmette, Illinois. His interests include, skiing, travel, and Rotary Club civic involvement.

**Bud Ross** is a Life Member of AFPAAA, and is currently its Vice President. He completed 25 years in the Air Force as a public affairs officer, culminating in his assignment as dual director of public affairs for the U.S. Transportation and Air Mobility Commands during the DESERT STORM Gulf War and Somalia relief operations. He retired as a Colonel in 1993 to become publisher of the O'Fallon Progress newspaper in Illinois. He returned to his native state in 1999 to become President and CEO of the Fairfield-Suisun Chamber of Commerce. He retired from that position in 2002. He served on the Military Affairs Committee of the Leadership Council of Southwestern Illinois, was president of the Friends of Scott, is a director and past chairman of the Travis Regional Armed Forces Committee and board member of the Northern California Retired Officers Community, the governing body of Paradise Valley Estates military retirement community.

**Hal Smarkola** is a Lifetime Founding member of AFPAAA and is currently a member of the Board of Directors. Hal completed 30 years of service in the Air Force, all of it as a public affairs professional, retiring from his position as Commander, Air Force News Agency (AFNEWS), Kelly AFB, Texas, in 2001. During his career, he served at Wing, FOA, MAJCOM, and HQ USAF level, including tours as Deputy Director, SAF/PAD, and Director of Public Affairs, SAF Acquisition (SAF/AQP). He also served as the Deputy Director, USAFE/PA during Desert Shield and Desert Storm. At his retirement, the enlisted men and women of the Air Force News Agency, an Air Force FOA, presented him with the "Order of the Sword", one of the few ever presented to a member of the Air Force public affairs community. He is currently lives in San Antonio with his wife, Peggy.

# Lord Guard & Guide

## Roger G. Maynard

It is rightly said that “NCO’s are the backbone of the Air Force”. The capable, dedicated, hard-working NCO turns young men and women into professionals, often setting an example that helps mold the rest of their lives. Without great NCOs, the Air Force would not be what it is and has been.

The best NCOs work quietly, more often than not in near-anonymity. They lead their younger charges with quiet competence, enhancing commands that assure mission success. The indispensable NCO is found in every career field and every period of time.

When Chief Master Sergeant Roger G. Maynard, died in his sleep February 8th in Pullman, Washington, a giant among the NCOs of his time in the Air Force radio and television service left knowing he had well performed his duty.

Born in Manhattan in 1932, Maynard spent his early years in New York City, and later in Pennsylvania. He joined the Air Force in 1951, and was assigned to an AFRTS station in the Philippines. There he married Lucy Quiano, who would celebrate almost 58 years at his side. Lucy is now cared for in a special home near Pullman.

After a long career serving at AFRTS stations around the world – Japan, Turkey, the Azores, Spain, Roger left a pleasant Mediterranean post on the Greek isle of Crete to become NCOIC of the 7122d AFRTS Squadron at Ramstein AB, Germany.

There he supervised a massive change of personnel throughout the squadron and its several detachments, directing shipments and dispositions of new, state-of-the-art equipment, and constantly developing an array of bright young broadcasters. A then new arrival at Ramstein, civilian Charlie Campione served as the 7122d’s senior engineer, recalls, “You talk about dedicated to AFRTS. Roger lived and breathed AFRTS.”

By then Roger was no longer on the air, instead he was applying his lengthy experience to bring to U.S. forces and families in Europe previously unavailable broadcast and telecast news and entertainment.

He retired in 1980. After serving as a civilian with Navy Broadcasting, Roger and Lucy resumed their globe-trotting ways.

“My dad and mom traveled a lot after he retired. They spent a year or more in Greece, mostly on someone’s yacht, having the time of their lives. They also traveled to many other countries before returning to the states. It was hard to keep up with them.”



“We never knew where they were until we got our classic ‘Wish you were here’ t-shirts and post cards from them,” daughter Patti Maynard Druffel recalls.

In failing health for some time, Chief Maynard moved in 2007 to be near daughter Patti, whose family raises wheat and barley on a farm near Pullman. He was preceded in death by a son and a daughter, and is survived by his wife, Lucy, daughter, Patti, 10 grandchildren, and 6 great grandsons.

Interment for Chief Maynard will be delayed until after Memorial Day, when a new National Cemetery opens in Spokane, WA. “A fitting date, if you ask me,” said retired Master Sergeant Joseph C. Chiglinsky, one of the AFRTS professionals who developed under Chief Maynard’s leadership.

One of that quiet, nearly anonymous group of NCOs who form and always have formed the “backbone of the Air Force”, Chief Maynard will be remembered by scores of Air Force broadcasters and public affairs people.

## Charles H. Powers


Charles “Charley” H. Powers, a Lifetime Founder of AFPAAA, who was Chairman of the Board in 2005-2006, passed away January 3rd in Alexandria, Virginia, after a short bout with bladder cancer. He was 64.

Charley was born in New York City. He obtained his bachelor’s degree from the University of Miami in 1965. His Air Force career began in 1967 when he was commissioned through AFROTC while getting his master’s degree in film at New York University.

Charley was uniquely skilled in Public Affairs in both the civilian world and in the Air Force. While a reporter with WJLA-TV in Washington, DC, in 1974, he helped break the Representative Wilbur Mills-exotic dancer Fanne Foxe jumping into the Tidal Basin story. Shortly after he became press secretary for the Senate Finance Committee. He was a deputy assistant secretary of public affairs in the Reagan Treasury Department, deputy assistant secretary for public affairs at the Transportation Department during the George H.W. Bush administration, and was on Elizabeth Dole’s press staff at the 1996 Republican National Convention.

On active duty he served at Bergstrom AFB, where he was made an Honorary Texan by Lyndon Johnson, in Southeast Asia, and at the Pentagon. He moved into the Air Force Reserve and made several motion pictures for the military until he retired in 1988 as a Lieutenant Colonel.

Most recently, Charley became a senior vice president at the Porter Novelli public relations firm and later started his own company, Powers Public Affairs LLC.

He is survived by his wife of 36 years, Rosalind Silverstone of Alexandria; and two children, Alex Powers and Greg Powers, both of Alexandria. (continued)

*In between those two "yesses," Charley's life was full of surprises and a successful career in politics, government and corporate PR. When we last talked before the holidays, he told me about his newest venture, Powers Public Affairs LLC. He seemed excited, motivated. But, that was Charley.*

*I was in my car when Roz reached me with the sad news. After offering my condolences, I asked her to e-mail me the particulars, since I was driving. That was a ruse. In reality, it was too hard to talk. When Roz hung up, I pulled over next to an orange grove and cried. I did. I mourned the loss of a valued friend, I mourned the loss of an engaging character who loved his family, friends, life, art and, selfishly, I mourned all the good times we won't get to share.*
